Small Diameter, Water Main Updates:

- 2021
 - o Two contracts awarded in 1/22, construction started in mid-March
 - o 6.3 miles of water main, 950 public service lines
 - Construction planned to take 1 year
- Contract B updates regarding work in Central Oakland, Lawrenceville, and Highland Park
- Contract C updates regarding work in Hazelwood, Squirrel Hill, and Point Breeze
- SDWMR Update
 - Over 97% of water main construction complete
 - About 97% service lines verified
 - 35 percent public, 31 percent private lead
 - Much closer to anticipated levels of lead than experienced in BRT or 2020 SDWMR
 - Work is going well
 - Will probably wrap up in another 2 months or so
- Overview of completed replacements, planned future work, and active works zones using map
- 2021 SDWMR Update
 - o 920 of 945 locations verified
 - Most private lead has been replaced, not much remaining on public side
 - 2 condemned properties; abandoned service lines
 - o 1 termination
- Other Water Main Work
 - Fuchsia Way
 - Replacing sewer in addition to water main
 - Phase 1 replaced, phase 3 to start soon
 - Temporary water main required since water infrastructure sits on top of sewer
 - Southside Flats Sewer Separation
 - Constructing separate stormwater system from sewer
 - Replace water main on 2 streets after stormwater work
 - Remainder of project area added to 2022 Neighborhood LSLR (D-16)
 - 2022 Water Relay Project
 - Remaining work includes Garfield and Brereton Street Ligonier Street added to 2023
 SDWMR Project
 - 2023 Water Relay Project
 - Planning includes Logan Street (pending landslide repairs, Kennedy Ave and Zulu Circle)
 - Will likely start up in June
 - Lead Statuses
 - Not too much lead found in Fuchsia
 - Already made a pass through in 2019
- Future SDMWR Update
 - o 2022
 - PENNVEST \$77M loan and \$6M grant



- 3 contracts about 10 miles of water main and 1900 service lines to be replaced
- PENNVEST closing early July 2023
- 1,900 agreements mailed last week
 - Ahead of schedule
 - LSLR agreements to follow
- o 2023
 - Awarding design contracts in March 2023
 - Anticipated start of construction mid-2024
 - 2 contracts about 12.7 miles total, number of service lines to be determined during design
 - Full project contingent on PENNVEST funding (about 6 miles in CIP)
 - 1 of 2 contracts will be awarded regardless of PENNVEST outcome

Active LSLR Activities:

2022 Priority LSLR – PENNVEST

- Complete other than street restoration of 4 locations
- Planned completion no later than 4/30/23

2022 Neighborhood – American Rescue Plan funding

- City approved 17.5M in funding from American Rescue Plan Act
- Contracts awarded 1/22 and construction started 4/22
- Funds anticipate work at about 1,400 locations and replacement of 725 public (and associated private) service lines
- Work complete in North Oakland, South Oakland, East Allegheny/North Shore, Elliot/Crafton Heights and East Liberty
- Finishing Bloomfield in a couple of weeks moving to Southside Flats
- So far added over 500 locations added to program and will likely be able to add more
- Not seeing as much lead in these neighborhoods compared to previous contracts
 - Have looked at data and are trying to understand why there is less lead in these areas than others
 - o Bloomfield had main replacements done in the 80s, could be reason for less public lead there

2022 Urgent LSLR

- Will replace private lead when encountered during PWSA Ops work
- Also includes contingency for public side in event PWSA staff are not available



• Annual contract started in March – new contract will be bid soon

Future Lead Activities:

2023A Neighborhood LSLR

- PENNVEST approved \$9.7 M grant and \$3.7M loan
- Bidding soon will close July 6 with construction starting shortly after
- Allow work at about 1200 locations
- Updated prioritization model
 - Women of childbearing age and children
 - Blood lead levels
 - o Amount of lead we believe is in the neighborhood
 - o Income level
 - o Census data
 - Neighborhoods:
 - Esplen
 - Lincoln-Lemington-Belmar
 - Perry South
 - Bluff
 - Marshall Shadeland
 - Taking another pass in areas we've been in before, cleaning up locations we were not able to access before

2023B Neighborhood LSLR

- Applying for additional \$15M in funding in May 2023
- If approved in August, construction will start around beginning of 2024
- Another 1,200 to 1,500 locations
- Presented a question for input from CLRAC regarding neighborhood selection for the next LSLR program. Continuing with Priority level 5 neighborhoods from the last prioritization model run will include neighborhoods with higher incomes. As an alternative, we could select Priority Level 4 neighborhoods starting with the lowest income to conduct our work.

- Will replace private lead when encountered during PWSA Ops work
- Also includes contingency for public side in event PWSA staff are not available
- Annual contract started in March new contract will be bid soon

Opt-Out Status

- · Locations opting out because they think private side is non lead are being verified
- If private lead is found, homeowners notified and given option to opt-in

PWSA Status

- Abandon service lines at condemned properties
- Vacant properties PWSA replaces public line and leaves curb stop shut after following termination procedures
- No PWSA opt-out locations in current construction contracts

Outreach:

- Virtual public meetings with regular meetings to resume as new contracts come on-line
- Robocalls
- Lead help direct phone calls
- Door-to-door canvassing
- Directed outreach for locations verified private lead
- Project updates, including new 2023 water main replacement locations, found on PWSA website (links included on presentation for water main and LSLR programs)

Overall LSLR Progress

- 2022, 2023, and totals since 2016 data included via table graphic on presentation
- LSL replacement number 10,000 recently accomplished

Termination Updates

- 13 locations have been terminated since 4/2021
- No new locations since our last meeting
- Data table regarding letters and posting provided via presentation
 - Tremendous amount of activity associated with 37-day and 10-day letters and 30-day postings

Orthophosphate Update:

- 2022b compliance sampling 90th percentile level at 5 ppb!
- Conducted 5th liter sampling to determine potential impact of future LCRR results similar to 1st liter sampling at 5.18 ppb
- 2023a event started results in July
 - Sampling bottles provided to customers
- Continuing additional, ongoing monitoring to ensure proper application of orthophosphate
 - Made some adjustments last June
- At this point we are very pleased with the effectiveness of our CCT program
- Doing a lot of sampling and analysis from across our distribution system
 - Seeing very good results

Reimbursement Program Update (Julie Barg):

- PWSA rolled out the private side reimbursement program 10/1/2020
- Income based owner or tenant can qualify
- Any applicant 300 percent or below FPV can qualify for 100% reimbursement
 - o Income above that level is reimbursed on a tiered basis
- 87 locations have completed the process and submitted plumber invoice and ACHD inspection
- Other verification data also provided by Julie

General Updates:

- Table of PUC settlement requirement status included in files
- Web map of service lines updated monthly
- Customer request sampling program continues
